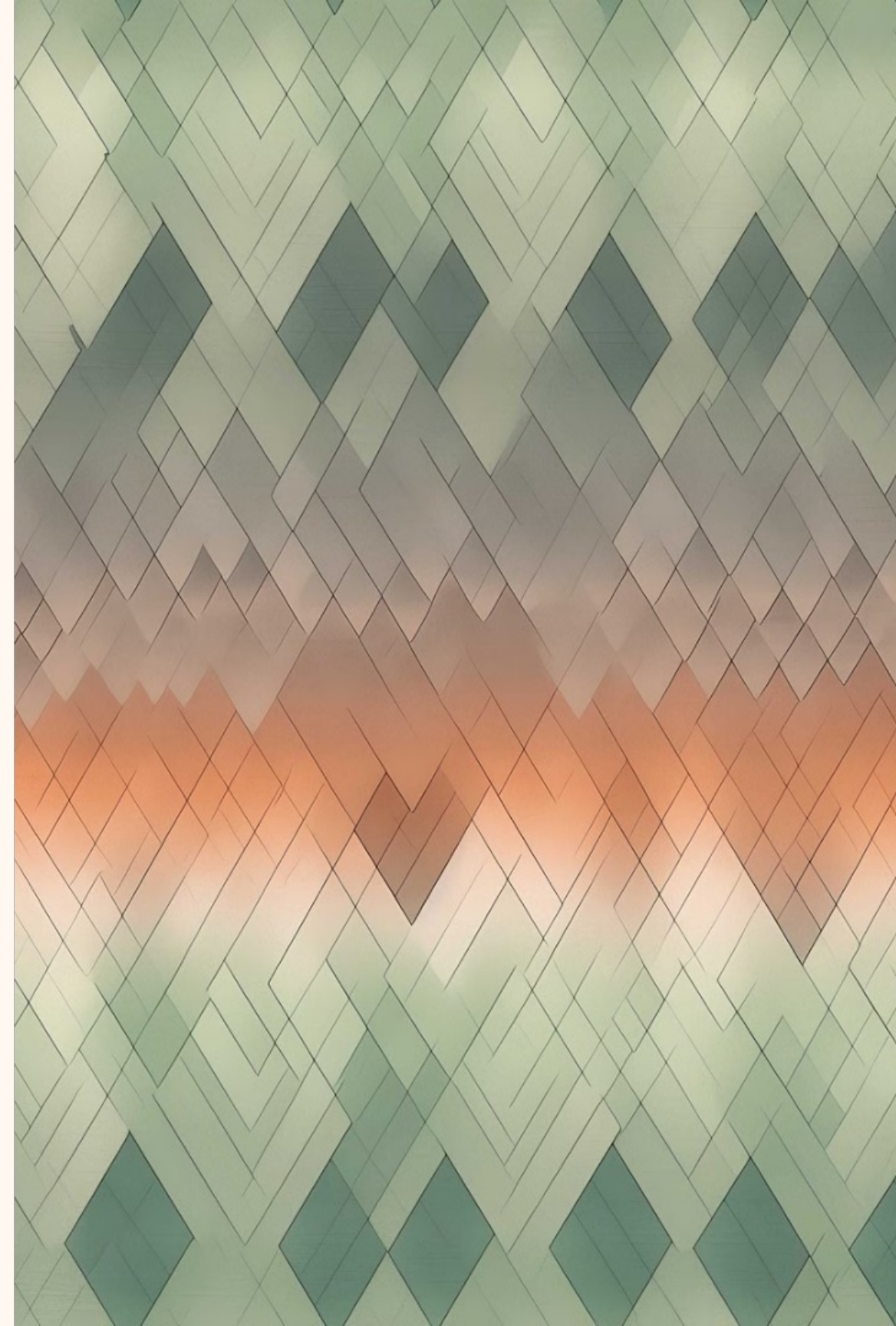

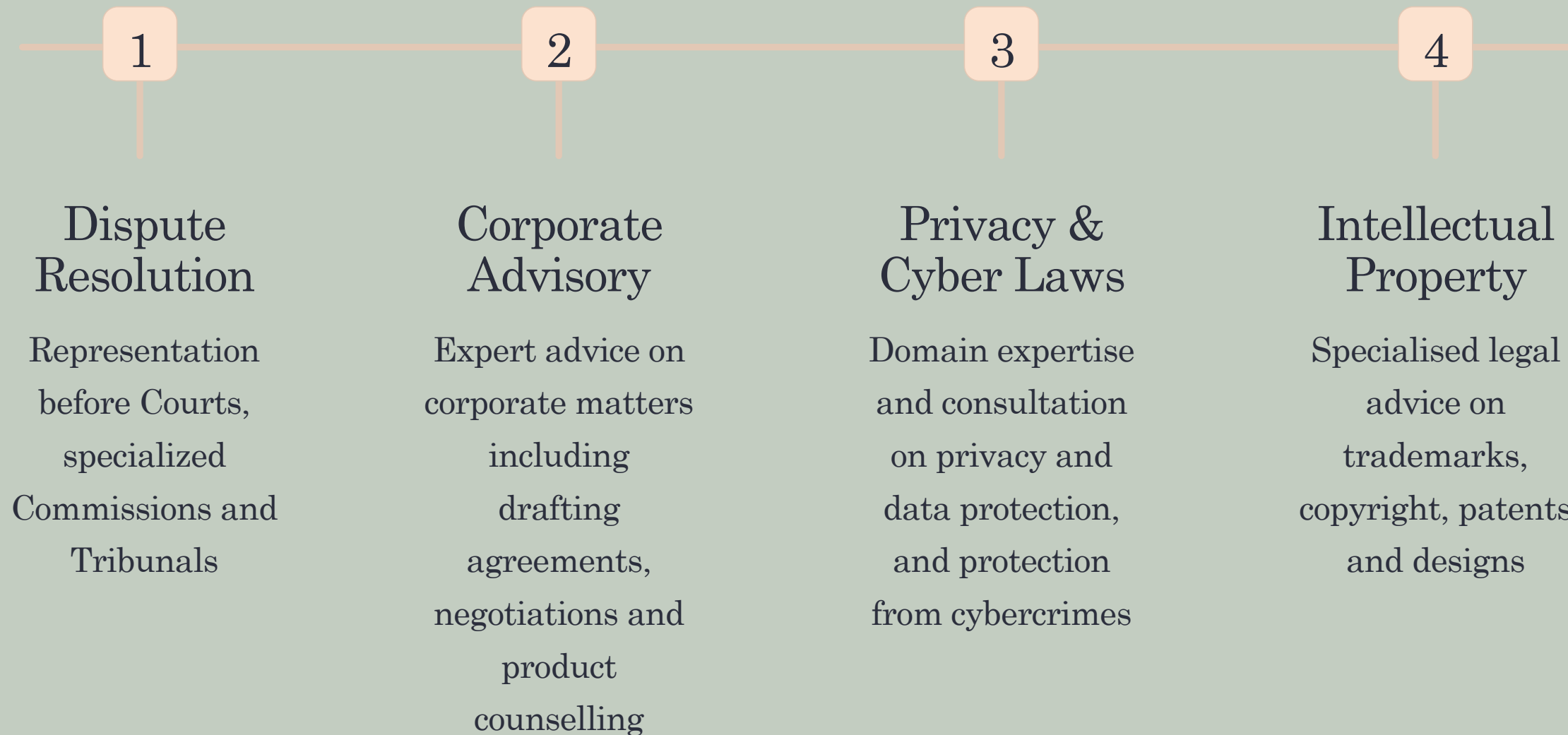

Comprehensive Advisory for Start-Ups : The Four Pillar Approach

Pillar 1 (Incorporation + Structuring)

Expert assistance with structuring, incorporation, and product counselling. This includes discussions on entity setup, stakeholders, and business geography. It will also include assessment of the legal and regulatory implications of the business.

Pillar 2 (Regulatory + Financing)

Guidance on and filing of regulatory/ licensing requirements, and financing strategies basis the short term and long term needs of the entity. For most tech-first entities, at this stage, backend tech agreements and service contracts will be drafted and negotiated as well.

Pillar 3 (IPR)

Building and registering the entity's IPR portfolio, including copyrights, trademarks, patents, and trade secrets (protected through NDAs).

Pillar 4 (Policies + Contracts)

Development of entity-wide agreements and policies such as ESOP Policy, Privacy Policy, Terms of Use, Employee Agreements, and POSH frameworks.
